

MRC Terms of Appointment

From Resolution C-79-99: Resolution Establishing Operations and Procedures for the MRC: *There shall be a total of 13 voting members on the Marine Resources Committee during the first year of operation. Following that initial period the members of the MRC may petition the Island County Board of Commissioners to have more seats to better insure adequate representation to achieve the work plan of the MRC. Within the 13 members, there shall be three from each commissioner district, one from WSU Extension, and the remaining three being selected from nominees by the three commissioners together.*”
