PROJECT PRIORITIZATION:

Kelly explained that there are two pots of money that the MRC is working with for this year. The first is \$16,562.50 available for 2nd year funding through the NWSC. Kelly recommends that the committee use these funds to fund the Port Susan MSA and for monitoring pre and post restoration sites on Whidbey Island. The 2nd pot of money is new Congressional Funding in the amount of \$200,000. We are still waiting to hear more details about how the funding can be used.

The committee worked together in a prioritizing exercise in the Mural website. Members were able to mark the projects they found to be the most important. These are the projects they came up with and the allocated amounts of funding included. The amount of funding included are best guesses and we will work to get a more defined budget for each project. The committee additionally chose project leads for the new projects. Each project lead will be responsible along with staff to identify the budget and deliverables of their proposed project by the next MRC meeting in May.
