## ISLAND COUNTY WATER QUALITY PROGRAM

Sage Ince and Carlie Miller presented to the MRC about the Surface Water Quality Testing that is being conducted in Island County.

- They monitor surface water associated with various watersheds. Through partnering with the On-Site Septic team, Watershed Planning, and the community, sources of pollution are addressed (e.g., fixing failing septic systems, implementing farm plans). This work helps ensure that shellfish beds are safe for harvest, salmon have healthy habitat, and kids can wade in clean water.
- Surface Water Quality Monitoring Plan:
  - Priority Watersheds and Source Identification (SID) Sampling Identified using the SWQMP prioritization process (Greatest # of fecal exceedances, presence of valuable resources)
  - Core and Rotational Site Sampling Previous baseline sites were reviewed and categorized into two new site lists: Core and Rotational
  - Effectiveness Sampling Show how a project affects water quality Collect pre and post project data
  - Reconnaissance Sampling Explore water quality outside of the regular core sites to identify watersheds with water quality impairments that may need further investigation -Based on presence of priority resources and estimation of current risk of pollution
- The main items they test for are, Temperature, Dissolved oxygen, pH, Turbity, E. coli
