HYBRID MEETING

CALL TO ORDER: Jill called the meeting to order at 3:00pm. INTRODUCTIONS: Introductions were made. QUORUM: A quorum was declared. AGENDA: Agenda was altered to include an update from Caitlyn Blair and the Northwest Straits Foundation, and Barbara Bennett's submission of the endorsement draft text for the Deer Lagoon Plan. The agenda was approved. MINUTES: A motion to approve the Minutes from June was made by PaulBen McElwain, seconded by Andi Kopit, and approved unanimously. Kelly Webb noted two corrections to the minute prior to approval, and a motion to approve the Minutes from August was made by Scott Chase, seconded by Ken Collins, and approved unanimously.

Jen Schmitz and Island County Department of Natural Resources did not receive this email and application until August 19th due to the new MRC Coordinator transition. The new applicant is Brad Thompson of Mutiny Bay and District 1. Per the August meeting discussion regarding the County's DEI consultant and BOCC decision to move from 3-year terms to 1-year terms, the MRC needs to decide how to move forward regarding new applicants.

Island County hopes to have the DEI consultants report by end of year. The MRC has been working to diversity it's membership and include new perspectives from the agricultural community, new community members of District 2 and District 3 as District 1 is well-represented and wants to continue including curious and objective members. There is currently one position open with two current MRC members leaving. MRC would like to invite potential new members to attend monthly MRC meetings. DNR will work to supply potential new members with listed responsibilities and code of conduct of MRC membership. Mr. Thompson reached out to Commissioner Bacon. Andi Kopit motions that Jen Schmitz/MRC Coordinator will respond to new applicant regarding Coordinator transition, MRC membership approval timeline, MRC Application, MRC Annual Expectations, and MRC Bylaws, seconded by Kelly Webb, and approved unanimously.
