CORRESPONDANCE: Jill brought up the question regarding whether the MRC can pay for member educational trainings. Trainings must connect and tie-in with one of the MRCs funded projects. The MRC Coordinator welcomes members to bring potential future trainings to the Coordinator for consideration.

LEADERSHIP REPORTS:

Report from Jen Schmitz – Last year's shoreline report catalyzed a lot of conversation at the State and Federal level. The September Ecosystem Coordination Board (ECB), a part of Puget Sound Partnership who reports to the Governor, have taken notice to the report and are very excited about the topic. MRC APPLICATIONS:

Island County DEI consultant update:

- Island County BOCC will hopefully be discussing the DEI recommendations at the Nov 5th work session. MRC Coordinator will continue to update the MRC as the discussion develops, but the MRC should plan to hold on new appointments until after Nov 5th.
- BOCC has said they will extend to a two-year term for those who joined this year. Extensions should happen automatically, and Jen coordinated with the County clerks and the resolution should be completed by EOY and will apply to all 2025 appointments.

New member recruitment update:

- Executive committee would like to prioritize having potential new members join at the same time for onboarding purposes.
- There is currently one open position and two current MRC members departing by EOY.
- We have received Island County and MRC applications from two interested potential new members, Brad Thompson and Fran Horvath.
- Per our November 2024 meeting, potential new MRC members need to attend at least 2-3 meetings and participate in an interview.
